ISEPP Speaks Out

The American Psychological Association solicited comments about updating its Code of Ethics in response to the overwhelming vote in 2015 by the APA Council of Representatives to ban psychologists' involvement in national security interrogations. ISEPP has also submitted a [letter to the Food and Drug Administration](#) with our concerns about the attempt to reclassify electroconvulsive devices for treating depression in adults.

ISEPP Supports Legislation

We have been in contact with the office of Representative David Jolly (13th Congressional District of Florida) and offered our support and assistance in the passage of his bill, [HR 4640](#), the Veteran Suicide Prevention Act, which calls for a study into the link between psychiatric drug use and veteran suicides. Specific ISEPP concerns are that the VA is not going to be eager about airing any evidence regarding such a link between psychiatric drugs and suicide. This is especially true considering the drugs have been the mainstay treatment for PTSD in veterans. For that reason, I suggested to the congressman that it would be appropriate to have an independent inquiry, not a VA conducted study, or at least have an independent review of the study by ISEPP. I am waiting for the response.
